- **RUNS: Sat, Nov 11<sup>th</sup>; Mon, Nov 27<sup>th</sup> ACT 1; Tues, Nov 28<sup>th</sup> ACT 2; Sat, Dec 2<sup>nd</sup> Evenings**
- **TECH: Dec 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, and 7<sup>th</sup>**
- **PICK UP REHEARSAL: December 14<sup>th</sup>**
- **PERFORMANCES: Dec 8 @ 7pm, 9 & 10 @ 2pm, & Dec 15 @ 7pm, 16 & 17 @ 2pm**

### COMMUNICATION:

- Check email **regularly** for updated rehearsal schedules and call (707) 442-7779 if you are not receiving emails from NCD.
- For rehearsals in the studio call (707) 442-7779 for any unexpected absence (such as illness), in a timely manner.

### SCHEDULING:

- **Fill out the audition form completely noting any conflicts.**
- If you remember a conflict after auditions, please email [northcoastdance.org@gmail.com](mailto:northcoastdance.org@gmail.com) right away.
- **If you miss more than 2 rehearsals (not listed on your audition form) or have inconsistent attendance, you may be removed from the Nutcracker.**
- **All parents of new NCD dancers, and Ballet 2 & 3 dancers must attend an informational parent meeting prior to Tech week. This meeting will answer questions of what to bring, makeup, hair, drop off and pick up procedures, etc. Date TBD. Please watch your email for scheduling.**
